#### 1 Top Import Countries in U.S.

As shown in Figure 1, Top 15 import countries in the U.S. are shown for this past October (2022.10). China is still the number one importer in the U.S. market, reaching a monthly total number of more than 1.1 million entries of imported records (lines). Behind China, Mexico and Canada take up the second and third place, respectively. Different from the previous month (2022.9) Italy surpasses Germany and holds the fourth place in October.

Note: According to U.S. CBP, "country of origin" refers to the country of manufacture, production, or growth of the article (product).

#### 2 Major Import Manufacturers




Figure 2: Leading Import Manufacturers by Import Records and Their Countries

Figure 2 shows the leading import manufacturers by import records and their countries. Figure 3 shows the top product categories by their manufactures, in desending order of the import records.



Following the trend of the country origins, these importers are mainly from China and Mexico, especially China. From the statistical perspective, in this past October (2022.10), companies from China dominated the U.S. MedTech/Medical Device import market.
